Introduction

The UK faces a range of threats from terrorism, espionage and state threats. Understanding the threats facing your business or organisation will ensure protective security measures are proportionate, effective and responsive.

The main threats to national security are terrorism, espionage, cyber threats, and the proliferation of weapons of mass destruction, many of which impact on the UK's national infrastructure.

National infrastructure sectors represent core strategic interests for foreign intelligence services, whose targeting against the sectors is likely to include espionage for economic, political, military, or commercial gain.

While the threat from terrorism to the UK as a whole is high, and historically both international and Northern Ireland terrorist groups have targeted UK infrastructure, the current terrorist threat to the national infrastructure can be characterised as generally limited and often aspirational. The exception is transport which continues to face enduringly high levels of threat from international terrorism. In addition, the emergency services and defence sectors, specifically police and military personnel, also face a high level of threat from both international terrorism and dissident republic groups in Northern Ireland, for whom they are a priority target for attack.

Generally higher levels of effective and visible protective security at national infrastructure sites are likely to act as a deterrent to terrorists, who increasingly favour 'soft' targets which allow them to achieve their aims with greater chance of success. Nevertheless, with the continual diversification of the threat, the ambition and capability of terrorist groups to target UK infrastructure is likely to continue to evolve.

UNITED KINGDOM'S THREAT DEFINITIONS

Terrorism Introduction

Terrorist groups use violence and threats of violence to publicise their causes and as a means to achieve their goals. Terrorism is a major threat for businesses. Terrorist groups may seek to cause harm to the economy as a whole by attacking business premises or they may seek to attack specific businesses to advance their political agendas. The threat is not confined to the UK; companies that do business overseas may also be targeted. The most significant terrorist threat comes from Islamist terrorism with its ambitions to mount high impact attacks designed to result in mass casualties.

Islamist terrorism

The threat to the UK from Islamist terrorism has increased and diversified, driven by developments in Syria and Iraq. The situation there provided an environment for terrorist groups, including Daesh (also referred to as ISIL, ISIS or the Islamic State) and AI Qaida (AQ)-linked groups, to plan attacks against the West. The availability of a large pool of individuals who have travelled from the UK and Europe to Syria heightens this threat. As these individuals return to the UK, there is a risk that a terrorist group will have tasked them to conduct attacks, they will seek to conduct attacks on their own initiative, or radicalise other vulnerable individuals.

Any organisation could be directly or indirectly affected by Islamist Terrorism. Acts of terrorism vary in scale and purpose. Some aim merely to inflict superficial damage or cause public distress to draw attention to a particular cause. But others can be more violent and indiscriminate with far-reaching consequences. The threat of terrorism emanates from the Middle East, North, East and West Africa, South and South East Asia. Here, Daesh-linked groups, as well as AQ and their affiliates, continue to pose a significant threat to UK interests overseas.

Extreme Right-Wing Terrorism (ERWT)

Extreme Right-Wing terrorism (ERWT) is made up of various different ideological strands that include but are not limited to, white supremacy. It is not a new phenomenon; modern ERWT ideology began to manifest in Western Europe during the 1970's, based on Nazi concepts and influences from the USA.

Since the 1970's there have been a number of notable RWT attacks both in the UK and worldwide, including: the murder of Rt Hon Jo Cox MP in 2016, the Finsbury Park Mosque attack in 2017, and the Christchurch Mosque Shootings in 2019.

In April 2020, the Security Services took over primacy of Extreme Right-Wing Terrorism investigations from the Police.

Northern Ireland-Related Terrorism (NIRT)

The nature of the terrorist threat in Northern Ireland has changed significantly in recent years. The Provisional Irish Republican Army (PIRA) and the main loyalist groups have ceased their terrorist campaigns and engaged with the political process. In April 1998 the Good Friday Agreement was signed, paving the way for a devolved Northern Ireland Executive based on power sharing between unionist and nationalist political parties. Although the Executive was suspended in 2002, it was successfully restored in May 2007 and has been in operation ever since.

However, some dissident republican groups reject the political process and the institutions created by the Good Friday Agreement and continue to carry out terrorist attacks. They seek to destabilise Northern Ireland through the tactical use of violence, targeting members of the Police Service of Northern Ireland (PSNI) and other security personnel as well as seeking to cause disruption and economic damage. They have very little public support.



Woman ends up in court after fly-tipper set fire to her two sofas

A woman who handed over a load of household rubbish to a man who dumped and burned it faces a hefty bill from the courts. Samantha Graham, 35, was prosecuted after she paid a man £30 to take her unwanted goods. The waste was fly tipped, set alight and ended up in a charred mess on grassland, Teesside Magistrates' Court heard.

A dump of two sofas, a shopping trolley, carpet and other items was reported to Middlesbrough Council. CCTV footage showed the unnamed man taking two sofas from the home on Enderby Gardens, Hemlington, Middlesbrough.

He put them over a fence on to a footpath, with a bed base or mattress and several trolley loads of waste, said Megan Worrall, prosecuting for the council on Tuesday (August 29). A scorched area with the remnants of a wooden frame and mattress springs was found near Enderby Gardens and Cass House Road. Graham admitted she paid £30 for a man to do some work for her but she did not have information about who he was. She did not provide a statement or pay a fixed penalty, which would have cost her £180 if paid in 10 days.

Nicola Sturgeon stripped of £600k VIP police security amid 'row' over spending

Nicola Sturgeon is being stripped of her £600,000-a-year VIP police security amid a behind-the-scenes "row" over the spending. Cop chiefs and the Scottish Government agreed to axe the 24/7 cover – still in place after she quit as First Minister in March.

But a source said there had been "pushback", though not from Ms Sturgeon, following threats to her in recent years. The ex-First Minister's close protection detail was extended after she left office at the end of March amid fears she needed the security, sources revealed. But after debate behind the scenes on the appropriate level of cover and justifiable costs to the public, insiders said Police Scotland and the Scottish Government are pulling the plug.

Former Chief Constable Sir Iain Livingstone, who retired this month, and the Scottish Government's top official, Permanent Secretary John-Paul Marks, signed off the changes. https://www-thescottishsun-co-uk

Irate Paignton driver rams police officer pinning him between vehicles

An angry Paignton man deliberately drove his car at a police officer then grabbed him while he was pinned in agony between two vehicles. Paul Schofield shouted "I hope that f*****g hurt" at PC Luke Holman who had arrived at the defendant's home moments earlier in response to an emergency call from Schofield's wife. The injured officer managed to fight off his attacker and retrain him at the scene until colleagues arrived to help. He suffered ruptured ligaments, bruises and a fracture in the incident. Schofield, aged 50, has been jailed for three years and nine months at Exeter Crown Court. The defendant, of Blagdon Barton, was initially charged with attempted murder but that charge was dropped. He admitted attempting to cause grievous bodily harm with intent.

Woman 'terrorist' told police and doctors' surgery in Wakefield she had planted bombs

Courtney Longstaff made the hoax claims that she had planted devices, first at King's Medical Centre in Normanton, and then at the police station in the town, telling them that she "hated the way the police treat people".

The 22-year-old appeared at Leeds Crown Court this week where she admitted three counts of making malicious communications.

Prosecutor Shannon Woodley said that walked into the Edward Street medical practice on March 31 and went into the women's toilets where she wrote a message on the mirror claiming to be a terrorist, that she wanted to kill people in a "gun attack" and that she had planted a bomb "somewhere". She left the toilet and told staff that a message had been written, so the emergency services were contacted, and the building was evacuated for more than three hours as a careful search was conducted. The court was told more than 30 appointments at the centre had to be cancelled.

Four days later Longstaff began a webchat on the West Yorkshire Police website from her home in Windross Close in Altofts in which she said: "I'm going to kill you and cut your f*****g throat." She then told them she had planted a device "in the entrance somewhere". Again, a search was carried out but no bomb was found.

Finally, on April 7, she contacted Cambridgeshire Police via their webchat, and told them she had again left a bomb outside the station in Normanton. However, after the internet IP address was recognised as being Longstaff's, the decision was taken not to evacuate. The court heard that she has five previous convictions for 15 offences, including possessing an offensive weapon in public, threats to kill and causing a public nuisance.

Mitigating, Rachel Webster said that Longstaff should be given credit for early guilty pleas, and that she was "deeply remorseful". It was heard that Longstaff had been on medication for mental health issues but had to be stop taking them because she was suffering from heart palpitations. No further mitigation was offered after Judge Christopher Batty said he would not send her to jail, describing her as a "troubled young lady who needs help". https://www.yorkshireeveningpost.co.uk



Newcastle bus hijacked by knifeman

A bus was hijacked by a knife-wielding thug so he could get home. Anthony Milner threatened the driver with a knife after getting on at a set of traffic lights in Newcastle by pressing the vehicle's external emergency button, opening the doors. Without speaking to the driver or attempting to pay, he went and took a seat. Newcastle Crown Court heard when the driver went to speak to him, Milner held a bread knife towards him, ordered him to "drive, drive" and said he wanted to be taken to the city's Central Station. Prosecutor Penny Hall said the driver diverted the bus and used a quicker route to get to the train station, where Milner left and dropped the knife. Milner was arrested, after a struggle with police, inside the station and officers found a small bag of cannabis on him when he was searched. https://www.chroniclelive.co.uk


TikTok craze led to five hours of chaos

For shoppers on London's Oxford Street, an evening of browsing and buying was thrown into chaos, with stores forced to shutter their doors as dozens of police officers descended on Europe's busiest shopping destination.

Over the following hours, several shoppers were forced to leave stores as officers formed human shields around shops in anticipation of violence.

A growing trend on social media calling for riots and looting in JD Sports, shared by hundreds of teenagers, had caught the attention of Met Police. The widely shared posts on TikTok and Snapchat began trending under the tag "Oxford Circus JD robbery", with youths encouraging others to congregate and loot stores along the street. A dispersal order has been put in place giving officers the power to exclude people from the area for 48 hours. It includes a number of Tube stations, including Piccadilly Circus, Leicester Square, Charing Cross and Covent Garden.

Home Office considers plans to put electronic tags on asylum seekers

The Home Office is considering fitting asylum seekers arriving in the UK via unauthorised means with electronic tags, it has been reported. The officials are mulling it as a way to prevent migrants who cannot be housed in limited detention sites from absconding, according to The Times. The Illegal Migration Act places a legal duty on the government to detain and remove those arriving in the UK illegally, either to Rwanda or another "safe" third country.

However, as spaces in Home Office accommodation are in short supply, officials have been tasked with a "deep dive" into alternatives, according to the newspaper. While the preferred solution is to increase the number of detention places, electronic tagging has been mooted, as has cutting off financial allowances to someone who fails to report regularly to the Home Office, the Times cited a source from the department as saying.

Police to get powers to seize and destroy machetes and zombie knives

The Home Office is banning more of the weapons and introducing a new offence for those found in possession - but Labour claims it is the "sixth time in seven years that the Conservatives have promised to outlaw zombie knives".

A new offence will also be introduced for possessing bladed articles "with the intention to endanger life or cause fear of violence". The maximum sentence for the importation, manufacturing, possession and sale of the weapons will be two years, the Home Office announced.

The government said the measures, first proposed in April, will be legislated "when parliament allows" and after a public consultation has taken place.

The possession of so-called "zombie" knives, which the government defines as a blade with "a cutting edge, a serrated edge and images or words suggesting it is used for violence", was made illegal in 2016. Under the new measures, the Home Office said the definition of a zombie knife would be expanded to include any bladed weapon more than eight inches long with a plain-cutting edge and sharp pointed end that also has either a serrated cutting edge, more than one hole in the blade or multiple sharp points like spikes.

The government hopes the changes will close a loophole which has allowed some dangerous weapons to be sold without breaking the law by removing certain banned features. https://news.sky.com



Every theft should be investigated, Braverman tells police

The Home Secretary will issue police forces with new guidance to investigate all thefts in a new push to increase solution rates for low-level offenses. Suella Braverman told the Daily Telegraph that all thefts will be investigated if there is a "reasonable line of inquiry" after her Home Office struck a deal on advice to be issued across England and Wales by the College of Policing. it emerged that more than three-quarters of burglaries reported go unsolved, amounting to some 213,000 burglaries in 2022. In June, the National Police Chiefs' Council (NPCC) confirmed that police would now attend every burglary.

The fall in investigations into these 'minor' crimes have been chalked up to austerity measures, as police have insisted they must focus on high-harm cases that impact the most vulnerable victims.

Chief constables have previously promised to investigate every crime reported with a "reasonable lead" in a bid to clamp down on "low-level" crimes.

A man has been fined almost £1,500 for flying a drone over one of the country's busiest airports to get footage of a festival. Daniel Cesare flew the device in the prohibited airspace above East Midlands Airport to get footage of this year's Download Festival, held at neighbouring Donnington Park in Castle Donington, Leicestershire.

Tesco staff offered body cameras over crime fears

Staff at Tesco stores are to be offered body cameras amid a rise in violent attacks, the supermarket's chief executive has said. The company has seen physical assaults increase by a third since last year. It mirrors findings by the British Retail Consortium (BRC) published earlier this year, which found abuse against retail staff had almost doubled compared to pre-Covid levels. Similar action has already been taken by Sainsbury's, Waitrose and Co-op. In the BRC's Crime Survey published in March, it recorded more than 850 daily incidents in 2021/22, a steep rise from pre-Covid level of 450 a day in 2019/20.

These incidents included racial and sexual abuse, something it said was having a "huge emotional and physical impact on people". The trade association, which represents more than 200 retailers in the UK, said the cost of retail crime was £1.76bn in 2021/22, with £953m lost to customer theft, and £715m spent on prevention. "The pandemic has normalised appalling levels of violent and abusive behaviour against retail workers," said Helen Dickinson, the group's chief executive.

In July, food retailer Co-op warned that some communities could become "no-go" areas for the company due to the rising levels of crime, which it said had increased by more than a third in the past year.

Met Police warrant cards, hackers stole details

The force spent £467,587 on the cards and civilian passes, a Freedom of Information request revealed, after security breaches at police buildings.

Forgery of old-style police IDs by villains for use in robberies and to dupe people into paying Covid fines was also behind the move. The disclosure comes after hackers stole details from the cards produced for the 47,000 cops and civilian staff in the London force.

Cyber crooks took the photo, name, rank, vetting status, payroll number and security details from a microchip on the IDs.

£1m counterextremism funding returned to Home Office

Almost £1m of unspent funding for counterextremism work has been handed back to the government despite a warning that "the risk from terrorism is rising".

The Commission for Countering Extremism (CCE) was formed by the Home Office following the 2017 Manchester Arena bombing, but the government has never publicly responded to any of its recommendations or reports. Since current commissioner Robin Simcox took the helm in 2021, it has published no new research or scrutiny of government policy, despite home secretary Suella Braverman warning last month that the threat to Britain is rising as attackers become "increasingly unpredictable" and harder to detect.

Shadow security minister Holly Lynch said tackling extremism "should be a top priority for this government".

"It is crucial that the commission is open and transparent about the work it undertakes and must demonstrate that it is upholding its obligations to provide impartial, expert advice and scrutiny," she added. Two men who toured London in search of designer watches have been jailed for a total of 22 years. Asonu McKenzie, 29, and Reshaun Nembhard, 29, both pleaded guilty to conspiracy to commit robbery between May 25 and July 15 last year.

The designer watch robbers were both sentenced at Southwark Crown

Court with McKenzie receiving a 14-year jail term and Nembhard being jailed for eight years.

Last summer over a two-month period, a series of robberies were carried out in Lambeth, Southwark, Bromley, Croydon, Wandsworth and Hammersmith and Fulham.

Suspected spies for Russia held in major UK security investigation

Three suspected spies for Russia in the UK have been arrested and charged in a major national security investigation, the BBC can reveal.

The defendants, all Bulgarian nationals, were held in February and have been remanded in custody since. They are charged with possessing identity documents with "improper intention" and are alleged to have had these knowing they were fake. It is alleged they were working for the Russian security services.

The documents include passports, identity cards and other documents for the UK, Bulgaria, France, Italy, Spain, Croatia, Slovenia, Greece, and the Czech Republic. The trio were among five people arrested in February on suspicion of an offence under the Official Secrets Act.

They were held by counter-terrorism detectives from the Metropolitan Police, which has national policing responsibility for espionage, and are due to answer police bail in September. Three of them were charged later in February with an offence under the Identity Documents Act. They are:

- Orlin Roussev, 45, of Great Yarmouth, Norfolk
- Bizer Dzhambazov, 41, of Harrow, north-west London
- Katrin Ivanova, 31, of the same Harrow address

Nottinghamshire fire service says naming 23 high risk buildings could make them terrorist target

Nottinghamshire Fire and Rescue says publicly naming the 23 buildings it has identified as 'high risk' could make them a target for terrorists. The service carried out a survey of the county's buildings following the Grenfell Tower disaster in 2017, in which 72 people lost their lives.

The survey resulted in 23 Nottinghamshire buildings, many of them high-rise, being classified as 'high-risk' due to factors such as external flammable cladding, poor compartmentation and fire safety defects. A Freedom of Information request was submitted to the service asking for the location of these buildings. But the service has declined the request, saying the information being made public would "likely endanger the safety of people". The service said it believed there was a likelihood of the buildings being targeted by people with malicious intent, such as terrorists or arsonists, if the information was disclosed. https://www.nottinghampost.com

Mayhem continued into the evening on Oxford Street earlier this month as flocks of youths have clashed with the police after a social media call for a "shoplifting rampage".

Organised shoplifting gang stole £70,000 worth of booze

The thieves targeted Champagne during their crime campaign hitting stores in London, Essex, Kent and Norfolk over a nine-month period. Valeriu Cobzarencu, Andrei Stefan, Vincentiu Gheorghe, Ionut-Razvan Gheorghe and Alin Chica targeted the likes of Tesco, Morrisons, Asda and Sainsbury's between November 21, 2021, and September 1, 2022.

Alcohol worth between £2,000 and £5,000 were stolen during each raid in towns such as Aylesford, Gravesend, Maidstone, Broadstairs and Dover, as well as Colchester, Essex and King's Lynn, Norfolk. On February 5 last year, they stole nearly £6,000 worth of alcohol from Sainsbury's in South Woodham Ferrers in Essex. Each of the men had distinct roles and worked together using earpieces and mobile phones to ensure vehicles were nearby to swiftly remove the stolen goods. Officers were able to build up a picture of the supermarket raids and they were all later arrested and subsequently charged with conspiracy to steal alcohol. The case concluded at Maidstone Crown Court on July 14 where 35-year-old Stefan, of Greater London, was sentenced to two years in jail.

Meanwhile, 30-year-old Cobzarencu, of the same address as Stefan, was sentenced to one year and eight months in jail. The other men were sentenced at a previous sentencing on July 7 at the same court. https://www-mirror-co-uk

Man who fled to Bulgaria to escape terrorism charges jailed after return to UK

A man who fled to Bulgaria after bomb-making manuals and videos of beheadings and terrorist attacks were found on his laptop has been jailed after being extradited back to the UK. David Bodill failed to show up at a court hearing last year after police discovered various chemicals and notes about how to mix them to create an explosive at his home in Buxton, Derbyshire, on March 2, 2020.

Analysis of the 29-year-old's devices also found extremist material from both extreme right-wing and Islamic terror organisations which showed attacks, beheadings and bomb-making tutorials, Derbyshire Police said.

After being charged, he failed to appear at Westminster Magistrates' Court last October and later told police he had fled to Bulgaria with no intention of returning. He was arrested by Bulgarian authorities in January 2023 and extradited back to the UK for his trial at Manchester Crown Court, where a jury found him guilty of an offence under section 4 of the Explosive Substances Act 1883. He was jailed for two years and six months at the same court.

Crime gang members sentenced for recruitment of illegal workers

Members of a criminal gang which recruited illegal migrants to work as cleaners across a string of Sainsbury's supermarkets in Oxfordshire and the South West have been sentenced. On 7 August, five defendants were sentenced at Oxfordshire Crown Court (pictured) over their roles in the organised crime group, whose members profited from the facilitation, work placement and housing of around 40 illegal workers, the majority of them hailing from West Africa.

The leader of the criminal group – namely Momodou Chune, aged 55, from Oxford – was jailed for six years after being found guilty of six counts of assisting unlawful immigration and three counts of concealing criminal property. He worked for two cleaning companies responsible for providing contracts for cleaners in nine Sainsbury's stores in Oxfordshire and Wiltshire. The defendants were caught following an investigation conducted by the Home Office's Criminal and Financial Investigations Unit.

It's estimated that, across a decade of activity, the gang profited in the region of £600,000 from the wages of illegal workers and 'ghost' workers. The majority of the illegal workers had more than one name and identity due to the fact that Chune created fake employees in order to obtain more money in false wages from his employers. https://securitymattersmagazine.com



Norfolk and Suffolk police: Victims and witnesses hit by data breach

A total of 1,230 people, including victims of crime and witnesses, have had their data breached by Norfolk and Suffolk police forces.

The constabularies said the personal information was included in Freedom of Information (FOI) responses due to a "technical issue". They said the data was hidden from anyone opening the files but should not have been included. It included descriptions of offences including sexual and domestic assaults. The forces have apologised for the breach. They said the information was attached to 18 responses to FOI requests for crime statistics issued by the forces between April 2021 and March 2022. The FOI responses were sent to individuals including journalists and researchers.

The data included personal identifiable information on victims, witnesses and suspects relating to a range of offences including sexual offences, domestic incidents, assaults, hate crime and thefts, the forces said. Victims of sexual offences should have lifelong anonymity under law.

People smugglers are providing passage in lorries from Santander on the north coast of Spain to Portsmouth for £14,000. The path means migrants are less likely to be picked up, identified and deported back to Albania. A 49-year-old Cheltenham man has been jailed for three months for racially abusing a John Lewis store security guard who he wrongly believed was Albanian. Prosecutor Simon Goodman explained to Gloucester Crown Court that Desmond Thompson of Pitman Road, St Marks, had gone into the John Lewis store in Cheltenham's High Street on November 4, last year and was looking around the shop's perfumery department in what the security officers described as being in a suspicious manner.

Thompson pleaded guilty to the racially aggravated harassment of a security guard at John Lewis store in Cheltenham on November 4, 2022. Judge Rupert Lowe told Thompson: "You have 182 previous convictions. That is an enormous number of offences. Three of these are for racially aggravated offences."

Man jailed after threatening to punch his dentist in the face and making bomb a threat

After verbally abusing his dentist, making a bomb hoax and spitting at police "embarrassed" John Fleming asked for a suspended sentence. But a court found his random spate of offences spanning from May last year to April merited a spell in prison. Fleming, 50, of Whitefield Road, Speedwell, denied a public order offence against the dentist and also denied making the bomb hoax, but he was convicted after trial. He pleaded guilty to racially aggravated public order; assault of an emergency worker; criminal damage; making a malicious communication, possessing a knife; a public order offence and a racially aggravated assault.

Judge Julian Lambert jailed him for 29 months. He told Fleming: "Most unfortunately, after a spate of offences by you, they just kept letting you go. I would not have done so. Now there are a raft of offences which need to be punished."

More than 20,000 migrants have already crossed the Channel in small boats this year

An average of around 60 people per boat. It means the provisional total for 2023 to date is 20,101, according to Home Office data. The figures show a drop compared to last year, when more than 25,000 people had already made the journey. Manchester Airport: Sham parking firm boss jailed

A man who "lied to customers" with a sham airport car service in which up to 500 vehicles were left in a farmer's field or on nearby streets has been jailed for 17 months.

Mohammed Isaq, 62, of Hale Barns in Cheshire, charged up to £70 to meet travellers driving to Manchester Airport, collect their cars and park them in a secure compound, covered by floodlights and CCTV.

But owners later found their vehicles damaged, scratched and covered with mud, Manchester Crown Court heard.

The three parking firms Isaq was involved with, operated one after another as each was dissolved, were Manchester Airport Parking Ltd, Manchester Airport Parking Services and Manchester Meet and Greet Ltd - all offering services on websites.

The court heard the combined turnover was up to £200,000 but the extent of the fraudulent trading was between £30,000 and £100,000.

Shrewsbury night club manager prosecuted

A Shrewsbury man was prosecuted at Doncaster Magistrates' Court on 28 June 2023 for managing illegal security at a Shrewsbury night club between 10 July 2021 and 04 November 2021. The court sentenced Kenneth Bailey to a £120 fine, ordered him to pay £500 prosecution costs and a £34 victim surcharge. During the investigation they discovered that he had worked without a licence on 14 occasions over a three-month period. The investigation identified that Kenneth Bailey was his manager and an SIA licence holder, and he performed the role of head doorman at the Buttermarket.

Mohammed Afzal, of Preston, posted extremist material that was deemed to 'encourage terrorism' on a number of social media accounts. He also collected terrorist information, including directions on how to make a bomb. He was arrested on suspicion of encouraging terrorism and the dissemination of terrorist publications, and later pleaded guilty to eight terrorism-related charges. He was jailed for three years and nine months at Liverpool Crown Court on Wednesday August 2.

Birmingham student accused of terrorism wanted to 'debate against' views of Islamic State

A University of Birmingham PhD student accused of plotting to make a drone capable of delivering a bomb was "fascinated" by so-called Islamic State because he wanted to argue against the terror group's views, a court heard.

The second day of the trial of Mohamad Al-Bared, 26, heard he was not a supporter of Islamic State and his work on a drone was part of research into removing heat from electric motors. Prosecutors alleged at the trial, at Birmingham Crown Court, that the mechanical engineering graduate, from Coventry, intended to supply terrorists with a drone to carry a bomb or chemical weapon.

He has denied a charge alleging he engaged in conduct in preparation of terrorist acts to benefit a proscribed terrorist organisation between January 1, 2022, and January 31 this year. https://www.birminghammail.co.uk

Covernment outlines core detail of all-new National Risk Register

An all-new register setting out the Government's latest assessment of key risks posed to the UK has been published as part of ongoing cross-Government work designed to better prepare the public and the business community for the threats facing the nation.

Deputy Prime Minister Oliver Dowden has unveiled the 192-page National Risk Register, itself an assessment of the risks facing the UK. The National Risk Register outlines no fewer than 89 threats that would have a significant impact on the UK's safety, security or critical systems at a national level. This latest version of the National Risk Register is described as being "more transparent than ever before" and publicly shares previously classified information about a number of potential risks. These include:

- disruption to energy supplies following Russia's full-scale invasion of Ukraine
- malicious uses of drones to disrupt transport and other critical operations
- threats posed to undersea transatlantic telecommunications cables used for the Internet and communications

The Government has "robust plans in place" for each of the different risks and is also urging businesses, local Government and voluntary groups to play their part in helping to plan for them. By publishing an online digital tool for the first time, the Government is making risk details more accessible and easier to navigate.

In fact, the National Risk Register's publication is the latest example of the transparent "whole of society" approach being taken towards national resilience, which was set out in the recently published UK Government Resilience Framework and the National Cyber Strategy. SIA Licence Renewals

You can't renew a licence unless you currently hold an active licence in that sector. This is because the legal permission granted by the licence ceases to exist when the licence expires. Once your licence expires it cannot be renewed, because there is nothing there for us to renew.

If your licence has expired and you wish to work in a licensable role, you need to apply for a new licence. The process is the same: we use the same application form, require the same documents and charge the same application fee. We will accept your renewal application up to four months in advance of when your current licence expires. If we have your email address on file we will send you a reminder that your licence is about to expire and explain what you need to do to renew it. However, we would like to remind you that:

Your licence expiry date is quoted in the letter we sent you when we granted it; it is also printed on the licence card and is featured in your entry on our public register of licence holders. You are responsible for ensuring that you apply for your new licence in good time. We cannot be held responsible if you apply late and are unable to work as a result.

We strongly recommend that you renew your licence as soon as you can.

Remember: there is no standard timescale for licence applications. The time taken to process your application will be affected by many different factors and so each application will be processed according to its own individual timescale. https://sia.gov.uk/

Latest Cifas data reveals range of fraud risks

In its half-year Fraudscape report, Cifas has revealed the range of external and internal fraud risks faced by today's organisations. These "substantial and growing" threats are outlined against a backdrop of additional legal requirements for organisations to put 'reasonable procedures' in place in order to prevent acts of fraud.

Between January and June this year, Cifas members recorded just over 186,500 cases of fraudulent conduct to the National Fraud Database. Particularly notable within these numbers is the scale and growth in attacks on both customers and companies. There have been upwards of 122,000 cases of identity fraud – which accounts for 66% of all cases recorded in the period – with plastic card and asset finance products particularly targeted.

A 180% increase is reported in the number of companies targeted for identity fraud, particularly so for telecoms and loan products. There was also a significant rise in criminals impersonating brokers in a bid to offer fake loans or other business services in order to harvest company details such that they could then impersonate the company.

The highest increase in cases relates to the takeover of existing facilities, which has risen by nearly a quarter (22%, in fact). This included the impersonation of banks to socially engineer victims to share their financial and personal information or otherwise make payments to a so-called 'safe account'.

Attacks against organisations also emanated from employees, which can have a devastating impact on an organisation's finances, staff and customers. In the first six months of the year, 151 instances of fraudulent conduct were recorded to the Cifas Internal Fraud Database, with nearly half of these (ie 46%) relating to dishonest actions by members of staff.

The Government's impending 'failure to prevent fraud' offence will mean that large organisations could be prosecuted if an employee or agent commits fraud for the benefit of the company where the organisation has failed to put 'reasonable procedures' in place to prevent the fraud.

Secured by Design issues Commercial Guide 2023

Secured By Design – itself part of the Police Crime Prevention Initiatives portfolio squarely aimed at crime reduction – has published its Commercial Guide 2023, which is the latest in its series of new/updated design guides. For the first time, the Commercial Guide is divided into Gold, Silver and Bronze Award gradations. Such locations would include retail premises, leisure centres, warehouses and public service buildings. Such developments may range in size from a single unit with a defined use to a group of buildings with multiple uses.

The Secured by Design Commercial Guide 2023 is said to be the most comprehensive publication of its type to date. It features contributions from a wide range of individuals, among them police designing out crime officers, members of the Fire and Rescue Service, trade and industry experts, access control professionals, local authority and building control practitioners and professors in the academic arena. *The Secured by Design Commercial Guide 2023 is applicable to all Secured by Design applications made after 1 August 2023. https://www.securedbydesign.com

The Electoral Commission flags major cyber-attack by "hostile actors"

The Electoral Commission has reported a cyber-attack perpetrated on its systems by "hostile actors". The incident was identified in October last year, in fact, after suspicious activity was detected. It became clear that "hostile actors" had first accessed the organisation's systems back in August 2021. During the cyber-attack, the perpetrators had access to The Electoral Commission's servers which held its e-mail system, control systems and copies of the electoral registers.

They attackers were able to access reference copies of the electoral registers, which are held by The Electoral Commission for research purposes and to enable permissibility checks on political donations.

The registers held at the time of the cyber attack included the names and addresses of anyone in the UK who

registered to vote between 2014 and 2022, as well as the names of those registered as being overseas voters. The registers did not include the details of those registered anonymously.

The Electoral Commission understands the concern this attack may have caused and has offered its apologies to all those affected. Since the attack was discovered, the organisation has worked with security specialists to investigate the incident and taken action to secure systems in a bid to reduce the risk of future attacks in the cyber domain.

National Cyber Security Centre widens Cyber Incident Response scheme

The National Cyber Security Centre has announced a change to its assured Cyber Incident Response scheme with the introduction of a new level. From now on, companies assured to offer Cyber Incident Response services will be designated Level 1 or Level 2, meaning that more companies will be able to provide high-quality incident response services to a wider range and larger number of victim organisations across the UK.

The National Cyber Security Centre's Cyber Incident Response scheme is well established and assists those organisations experiencing a cyber attack to quickly and easily identify trusted providers of commercial incident response services. These assured companies support organisations to investigate and recover from a cyber attack and advise on the prevention of future attacks.

Until now, the Cyber Incident Response scheme has focused on assuring companies that can provide incident response services to organisations running networks of national significance, such as central Government, Critical National Infrastructure organisations and regulated industries. These organisations are at particular risk of targeted and complex attacks organised by nation state actors.

All Level 1 Assured Service Providers are capable of dealing with all types

of cyber incident for all types of organisations. The National Cyber Security Centre "strongly encourages" organisations running networks of national significance to contact a Level 1 company if they experience a cyber attack. It's particularly important that all organisations use a Cyber Incident Response Level 1 provider if they think they've been the victim of a highly sophisticated attack episode.

Level 2 companies are assessed as being capable of supporting most organisations with common cyber attacks, such as those involving ransomware. This includes private sector organisations outside of Critical National Infrastructure sectors, charities, local authorities and smaller public sector organisations.

Vandals put 'spy' stickers over Ulez cameras ahead of expansion

The cameras have been targeted by anti-Ulez campaigners in a flurry of vandalism and thefts in the weeks leading up to the clean air zone expansion to the Greater London boundary on August 29.

In the latest show of discontent, photos show stickers that express opposition to Mayor Sadiq Khan have been placed over the lens of some Ulez cameras that have been installed

by Transport for London (TfL).

Underneath the camera, on the camera pole, red stickers with large white writing say "Ulez spy camera" with an arrow pointing up towards the camera. Other posters have been left on car windshields warning drivers of the charges being imposed on noncompliant vehicles.

City Hall faces wave of Ulez camera destruction

Activists claim to have destroyed or damaged roughly 600 Ulez cameras in the past few weeks. TfL is battling against protesters sabotaging some of the

almost 3,000 cameras needed to police the expansion.
